### TRAFFIC ORDER PROPOSALS – 40 MPH SPEED LIMIT AT BENTWORTH

Hampshire County Council proposes making a traffic order as follows:

**EFFECT OF ORDER**: will be to impose a 40mph speed limit (existing de-restricted) on the following lengths of road at Bentworth:

- (i) C36 Holt End Lane / Trinity Road between a point 200 metres south-west of its junction with U227 Holt End Lane and a point 180 metres south-west of its junction with U227 Jennie Green Lane, an approximate distance of 830 metres.
- (ii) U227 Jennie Green Lane between its junction with C36 Holt End Lane/Trinity Road and a point 704 metres east thereof.

The proposals will revoke and re-enact the provisions contained in an existing order with no change of substance save for minor amendments to descriptions, road names/measurements and the addition of the 40mph speed limits described above.

Hampshire County Council in exercise of its powers under Sections 82, 83 and 84 of the Road Traffic Regulation Act 1984, Part IV of Schedule 9 to the Act and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, hereby makes the following order:

"road" means any length of highway or any other length of road to which the public has access, and includes bridges over which a road passes.

- 2. No person shall drive any vehicle at a speed exceeding 30 mph on any of those lengths of road specified in schedule I to this order.
- 3. No person drive any shall vehicle at a speed exceeding 40 mph on any of those lengths of road specified in schedule II to this order.
- 5. No speed limit imposed by this order applies to vehicles falling within regulation 3(4) of the Road Traffic Exemptions (Special Forces) (Variation and Amendment) Regulations 2011 when used in accordance with regulation 3(5) of those Regulations.
- 6. The Hampshire (Various Roads, Bentworth) (Restricted Road) Order 1992 is hereby revoked.
- 7. This order shall come into operation on 2017 and may be cited as "The Hampshire (Various Roads, Bentworth) (30 and 40 Miles Per Hour Speed Limit) Order 2017."


# Roads at Bentworth/Holt End in the District of East Hampshire 30 mph Speed Limit

- (i) U227 Ashley Road between its junction with U227 School Lane/Church Street and a point 138 metres west thereof.
- (ii) U227 Burkham Lane between its junction with U227 Ashley Road/U227 Drury Lane and a point 50 metres north thereof.
- (iii) U227 Drury Lane between its junction with U227 School Lane/Church Street and its junction with C36 Village Street, an approximate distance of 476 metres.
- (iv) U227 School Lane/Church Street between its junction with U227 Ashley Road/Drury Lane and its junction with C36 Village Street, an approximate distance of 300 metres.
- (v) C36 Village Street between its junction with C224 Well Lane and a point 821 metres north thereof.
- (vi) C224 Well Lane between its junction with C36 Village Street and a point 340 metres east thereof.
- (vii) C36 Village Street between its junction with C224 Well Lane and its junction with U227 Church Street, an approximate distance of 520 metres.
- (viii) C36 Holt End Lane between its junction with U227 Church Street and a point 200 metres south-west of its junction with U227 Holt End Lane, an approximate distance of 1330 metres.

- (ii) U227 Jennie Green Lane between its junction with C36 Holt End Lane/Trinity Road and a point 704 metres east thereof.

### STATEMENT OF REASONS

At the County Council's annual highways workshop in 2013 County Councillors for the East Hampshire area approved the inclusion of the East Hampshire Minor Roads Speed Limit scheme in the East Traffic Management programme for the 2014/2015 financial year. One of the sites included was Holt End Lane/Trinity Road/Trinity Hill between Bentworth and Medstead where concerns had been expressed about safety generally and the speed of traffic specifically. Following initial technical assessments and consultations, for safety/speed-related reasons, it is now proposed to carry out the public advertisement of a lower speed limit in Holt End Lane/Trinity Road.




